**Section II****Donations**

A project for establishing a Research and Training Center and a Comparative Testing Laboratory for independently tests and verification of claims of various consumer goods and services has been planned to be completed with donations from individuals and institutions.

CRCP is engaged in a number of areas where special expertise is required to cross-examine data or undertake reviews from consumer perspective. CRCP encourages individuals who have relevant expertise and adequate motivation to work for consumer rights to make voluntary contribution on as-and-when-required basis.
